- 4. If the crane is not in use on any specific day that column should be left blank.
- 5. Any accidents, strange occurrence, accidental overloads etc. shall be recorded in the incidents page in the rear of this Log Book.
- 6. This Crane Log Book must be kept with the crane whenever the unit is in operation and be available for inspection at all times.
- 7. At the end of each week a photocopy of the Daily Crane Operator checks and notes is to be given to the workshop for their records and to alert them of any faults not reported earlier.
