The workers current "Site access plus periodic medical assessment detailed certificate" first page, has 'Opinion' (Green, Amber, Red) and the second page is signed off by the Medical Officer (Stating 'this medical complies with the requirements of the NSW Coal Order 41'. This must also be uploaded into the Pegasus system. Please DO NOT send whole of workers medical details, only the assessment certificate.

Please note: this approval is only for the person named above to attend the Generic Induction for Stratford Coal. Any site familiarisation for new contractors will need to be organised with your Site Contract Holder.

Appointments to work on site: For Statutory, Trades, Trainers & Assessors and others requiring appointments to work on site, the information and qualifications supplied must be supportive and creditable to gain an appointment for the classification application.
