"Purchase Order" means this Purchase Order, including these Terms of Purchase; "Purchaser" means the party identified on the front sheet of this Purchase Order to whom the Goods must be define red; and "Supplier" me anothe pany to whom this Purchase Order is addressed, as identified on the front sheet of this Purchase Order he addresses of the parties are stated on the front sheet of this Purchase Order. This Purchase Order including these Terms of Purchase will be deemed to be accepted by the Supplier for the delivery of the Goods and its other obligations under this Purchase Order from the Supplier's commencement of work relevant to the delivery of the Goods after receipt of this Purchase Order The Goods to be supplied by the Supplier are described in this Purchase Order. The Supplier warrants that the Goods will comply with any drawings, specifications and/or ofter technical documents induded with and/or identified in this Purchase Order or ofterwise provided by the Purchaser; comply with all relevant standards and statutory requirements benew (unless stated otherwise), of good mercha mable quality, free of defects and fit for their intended purpose; upon delivery to the Purchaser, be free of all liens, charges and other encumbrances; and be supplied to the Purchaser strictly in accordance with the terms of this Purchase Order except to the extent that the Purchaser may agree or direct otherwise in writing. GENERAL

 - ensure that only persons who are careful, skilled, experienced and qualified in their respective trades and callings are employed in connection with the delivery of the Goods (b) and hold all certificates and licences required by law inorder forthern to deliver the Goods; and comply with any direction that the Purchaser may give in connection with the delive:y of the Goods.

- CODE OF CONDUCT
