<b>Tradesperson. Licence. Plumbing (NZ)</b>	<ul style="list-style-type: none"> <li>Applicants name should be displayed on the evidence and should match the applicant name that's registered in Pegasus (However shortened versions of names such as 'Chris' for 'Christopher' is accepted).</li> <li>The uploaded evidence will show indication that the applicant is a qualified plumber</li> <li>Evidence will be issued by Plumbers, Gasfitters and Drainlayers Board</li> <li>Must be current</li> <li>Front and back of licence required</li> <li>Colour copy OR black and white copy is acceptable</li> <li>New Zealand recognises Australian qualifications held by registered plumbers, gasfitters and drainlayers under the provisions of the Trans-Tasman Mutual Recognition Act 1997 ("TTMRA") and we will issue the equivalent registration and practising licence.</li> </ul>	<ul style="list-style-type: none"> <li>Scanned document to be clearly legible</li> <li>Documentation which has been found to be subject to alterations will not be accepted.</li> <li>Issue Date: Not Required</li> <li>Expiry Date: As shown on the licence</li> </ul>	
<b>Tradesperson. Licence. Plumbing (AUS)</b>	<p><u>When Licence is uploaded:</u></p> <ul style="list-style-type: none"> <li>Applicants name to be displayed on uploaded evidence and to match applicants registered name</li> <li>'Plumber' / 'Roof Plumber' 'Plumber and Drainer / Gasfitter' or like be listed</li> <li>Screenshots from websites are not accepted - Must be copy of the Licence</li> <li>Must be issued by a relevant Australian state government authority with corresponding logo shown on licence - Licence from any Australian state is accepted</li> <li>Black and white or coloured copy of evidence can be accepted</li> </ul> <p><u>When Invoice (For new contractor Licence) has been uploaded:</u></p> <ul style="list-style-type: none"> <li>Applicants name to be displayed on uploaded evidence and to match applicants registered name</li> <li>'Plumber' / 'Roof Plumber' 'Plumber AND Drainer / Gasfitter' or like be listed</li> <li>Date of receipt to be displayed on the invoice</li> <li>Contractor number to be displayed on document</li> <li>Must be issued by relevant state government authority - Licence from any Australian state is accepted</li> <li>Black and white or coloured copy of evidence can be accepted</li> </ul>	<p><u>When Licence is uploaded:</u></p> <ul style="list-style-type: none"> <li>Expiry Date = The date of expiration on the evidence</li> </ul> <p><u>When Invoice (For new contractor Licence) has been uploaded:</u></p> <ul style="list-style-type: none"> <li>The date of expiration on the evidence should be recorded as the date which is calculated to be 4x weeks from the date of renewal completion</li> </ul>
